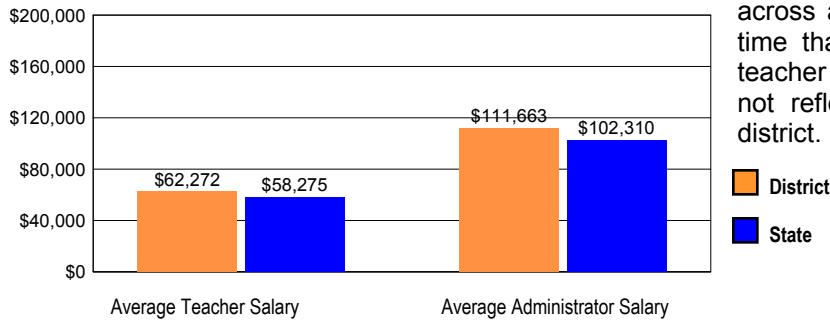

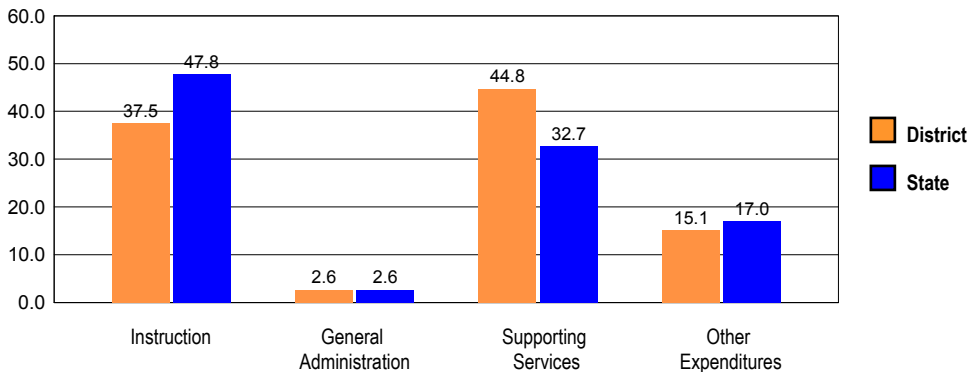
## SCHOOL DISTRICT FINANCES

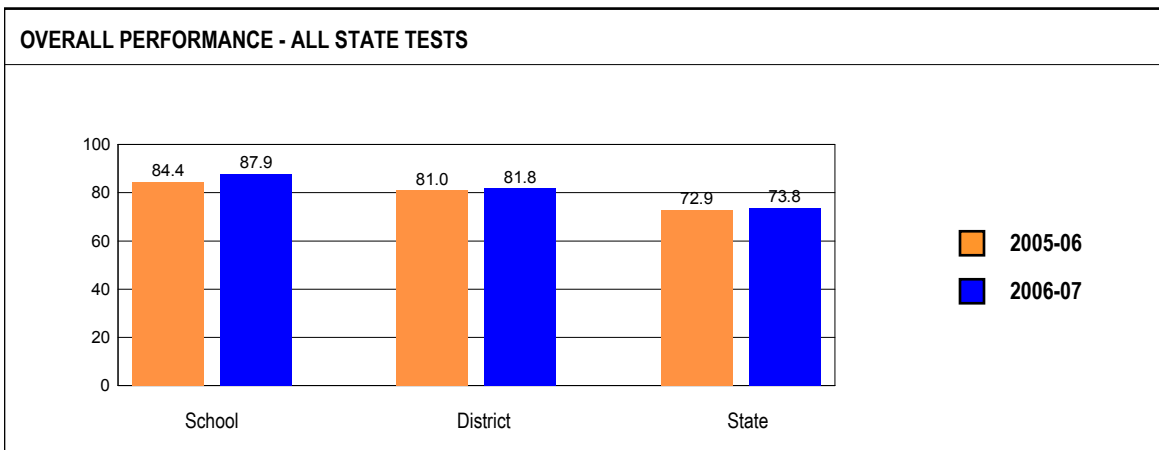

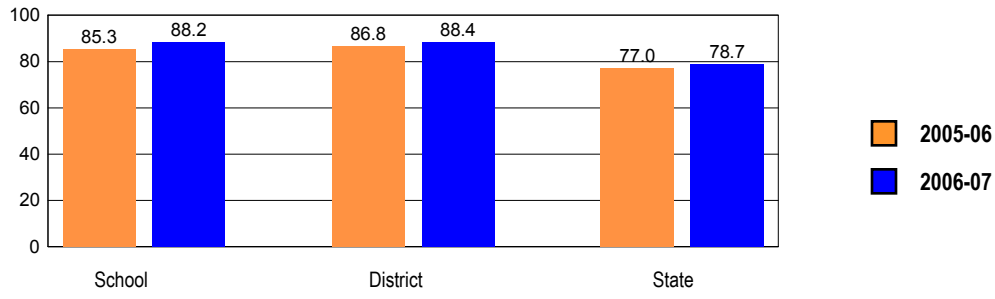

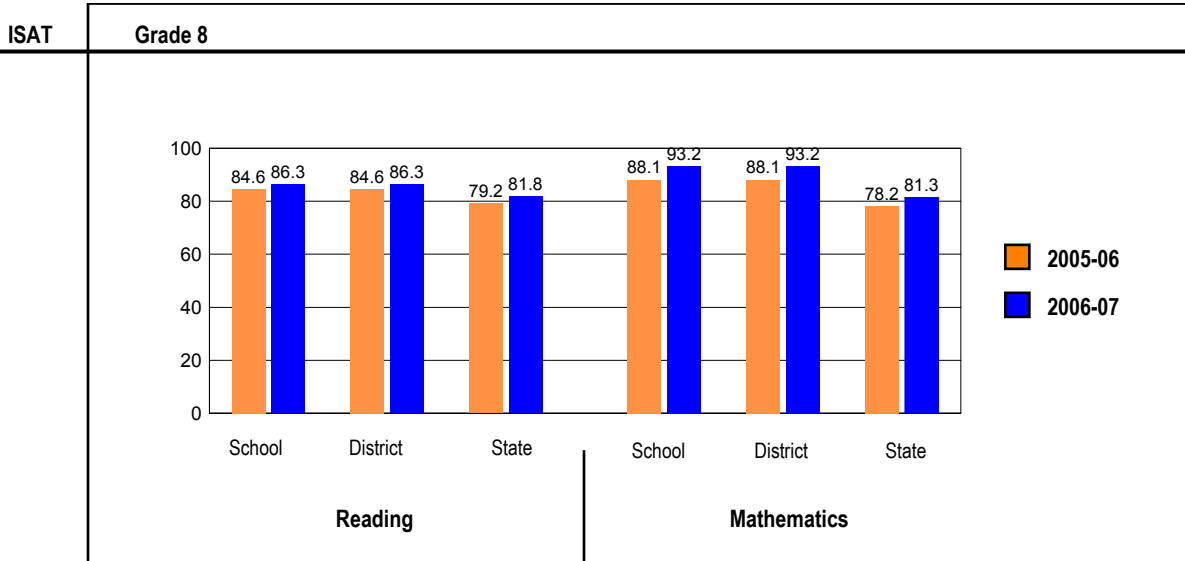
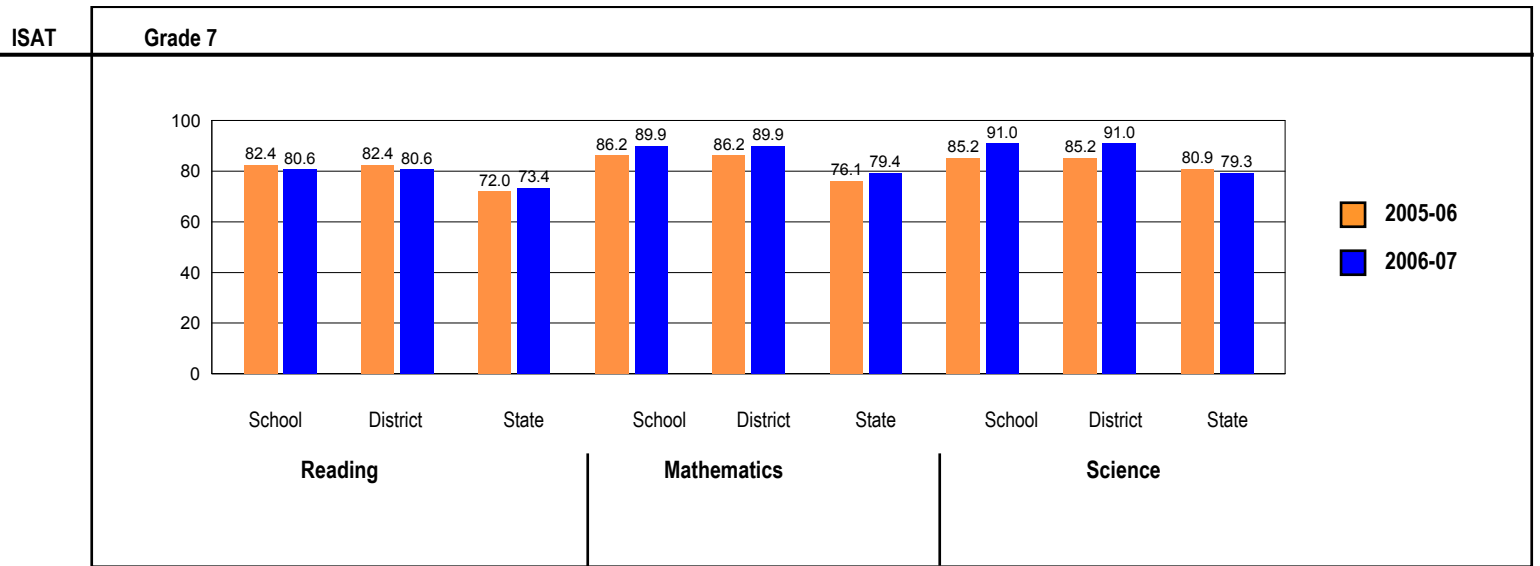


**OVERALL ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT) PERFORMANCE**



**ISAT PERFORMANCE**

**PERFORMANCE ON STATE ASSESSMENTS**

Federal law requires that student achievement results for reading, mathematics and science for schools providing Title I services be reported to the general public.

The Illinois Standards Achievement Test (ISAT) is administered to students in grades 3 through 8. The Prairie State Achievement Examination (PSAE) is administered to students in grade 11. The Illinois Measure of Annual Growth in English (IMAGE) is administered to limited-English-proficient students. The Illinois Alternate Assessment (IAA) is administered to students with disabilities whose Individualized Education Programs (IEPs) indicate that participation in the ISAT or PSAE would not be appropriate.

Students with disabilities have an IEP (No Child Left Behind Act). An IEP is a written plan for a child with a disability who is eligible to receive special education services under the Individuals with Disabilities Education Act.

In order to protect students' identities, test data for groups of fewer than ten students are not reported.

### ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT)

The following tables show the percentages of student scores in each of four performance levels. These levels were established with the help of Illinois educators who teach the grade levels and learning areas tested. Due to rounding, the sum of the percentages in the four performance levels may not always equal 100.

- Level 1 -- Academic Warning - Student work demonstrates limited knowledge and skills in the subject. Because of major gaps in learning, students apply knowledge and skills ineffectively.
- Level 2 -- Below Standards - Student work demonstrates basic knowledge and skills in the subject. However, because of gaps in learning, students apply knowledge and skills in limited ways.
- Level 3 -- Meets Standards - Student work demonstrates proficient knowledge and skills in the subject. Students effectively apply knowledge and skills to solve problems.
- Level 4 -- Exceeds Standards - Student work demonstrates advanced knowledge and skills in the subject. Students creatively apply knowledge and skills to solve problems and evaluate the results.

### Four Conditions Are Required For Making Adequate Yearly Progress (AYP):

1. At least 95% tested in reading and mathematics for every student group. If the current year participation rate is less than 95%, this condition may be met if the average of the current and preceding year rates is at least 95%, or if the average of the current and two preceding years is at least 95%. Only actual participation rates are printed. If the participation rate printed is less than 95% and yet this school makes AYP, it means that the 95% condition was met by averaging.
2. At least 55.0% meeting/exceeding standards in reading and mathematics for every group. For any group with less than 55.0% meeting/exceeding standards, a 95% confidence interval was applied. Subgroups may meet this condition through Safe Harbor provisions. \*\*\*
3. For schools not making AYP solely because the IEP group fails to have 55.0% meeting/exceeding standards, 14% may be added to this variable in accordance with the federal 2% flexibility provision.

## **PLANNED IMPROVEMENT FOR THE SCHOOL AND DISTRICT**

### AREAS OF SUCCESS:

1. Wauconda Middle School met Annual Yearly Progress (AYP) in all areas.
2. Ninety-one percent of all WMS 7th grade students met or exceeded state standards on the science subtest of the ISAT, which was superior to the state average.
3. Over eighty percent of WMS 7th grade students met or exceeded the state standards on the reading subtest of the ISAT, which was superior to the state average.
4. Over eighty-nine percent of WMS 7th grade students met or exceeded the state standards on the math subtest of the ISAT, which was superior to the state average.
5. Over eighty-six percent of WMS 8th grade students met or exceeded the state standards on the reading subtest of the ISAT, which was superior to the state average.
6. Over ninety-three percent of WMS 8th grade students met or exceeded the state standards on the math subtest of the ISAT, which was superior to the state average.
7. All teachers and support staff at Wauconda Middle School are highly qualified as defined by the *No Child Left Behind Act* of 2001.

### AREAS FOR THE PLANNED IMPROVEMENT:

1. To develop instructional strategies through the school improvement process to increase the percentage of all students meeting and exceeding the state standards on the science subtest of the ISAT.
2. To develop instructional strategies through the school improvement process to increase the percentage of all students meeting and exceeding the state standards for math and reading on the respective subtests on the ISAT.
3. To develop instructional strategies through the school improvement process to increase the percentage of all students meeting and exceeding state standards on the writing subtest of the ISAT.
4. To improve our attendance rate from ninety-three percent during the 2006-2007 school year to ninety-four percent for the 2007-2008 school year.
