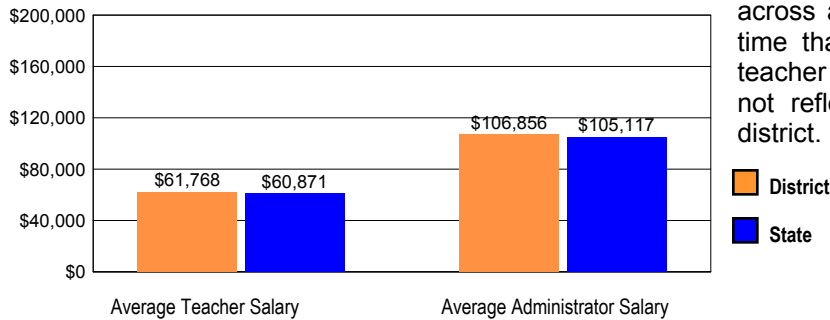

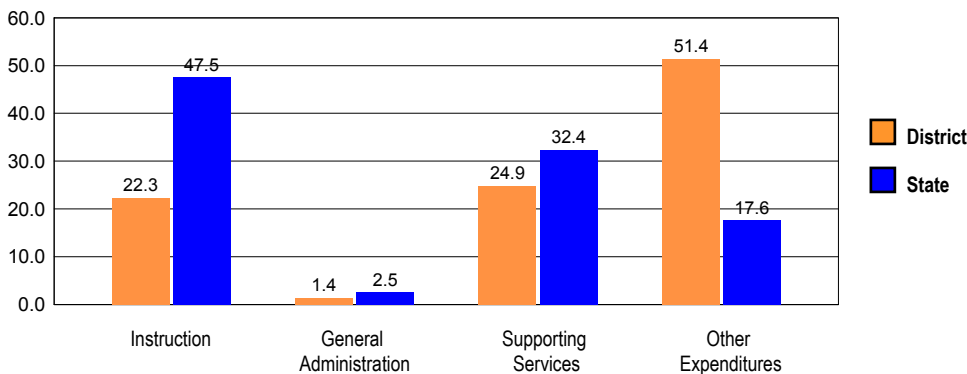
SCHOOL DISTRICT FINANCES

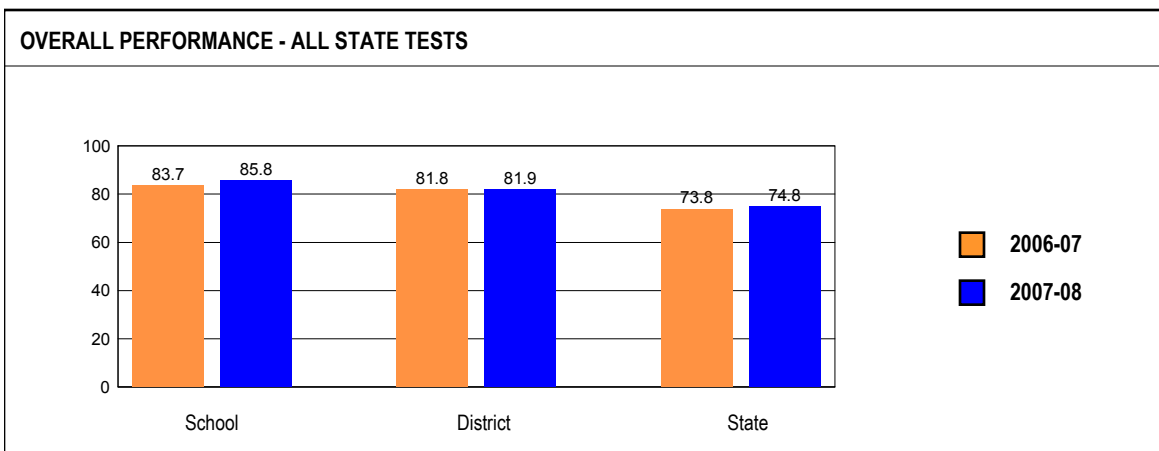

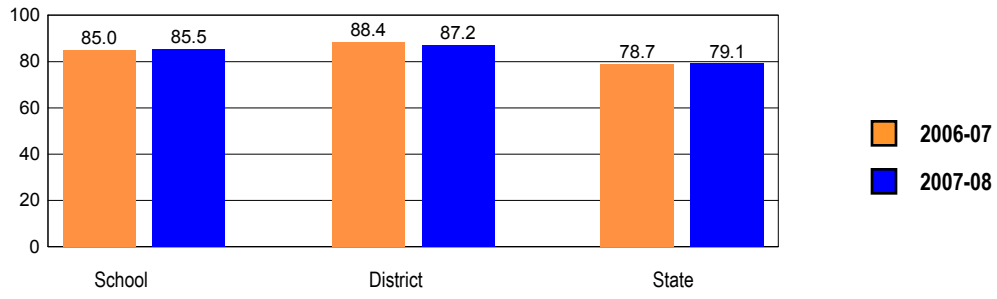
OVERALL STUDENT PERFORMANCE

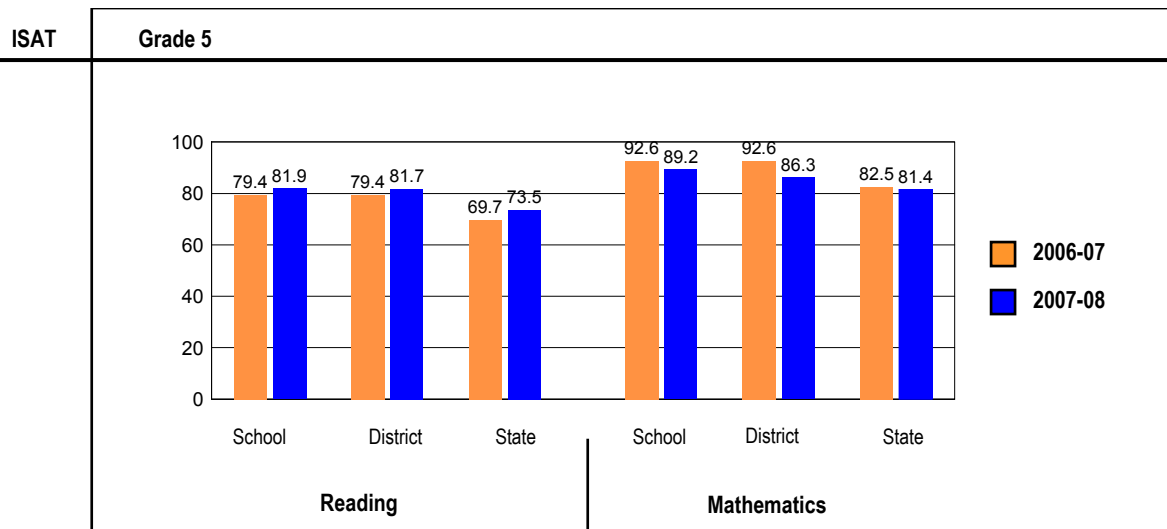
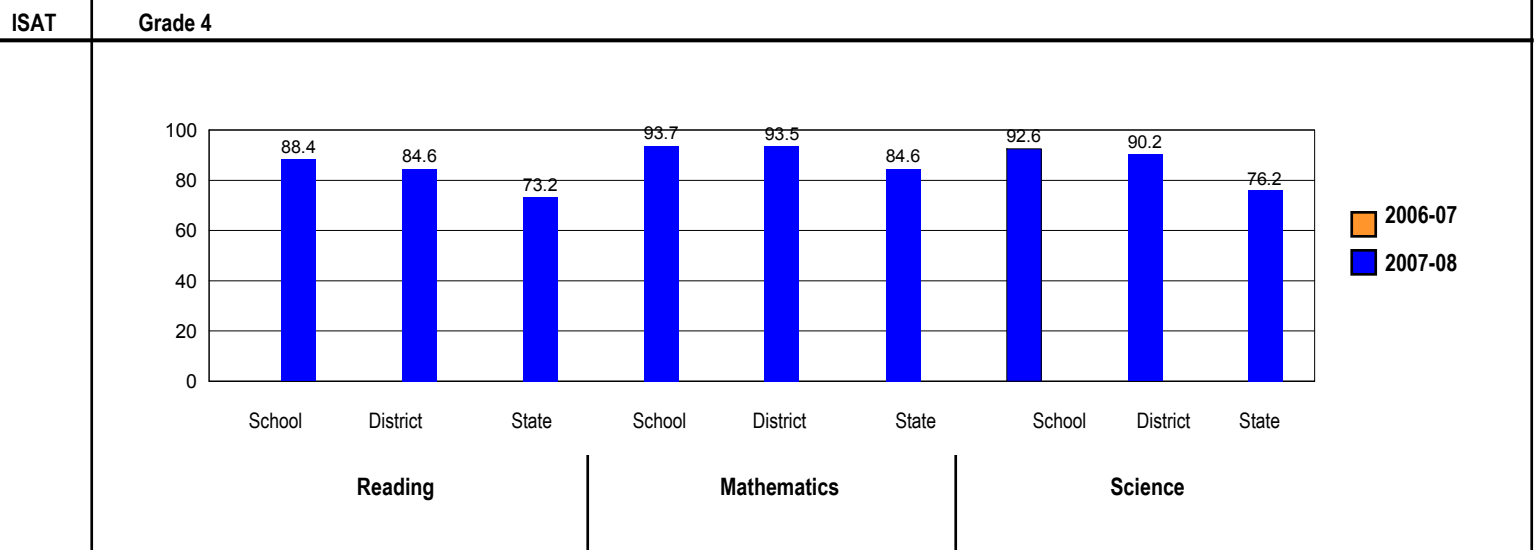
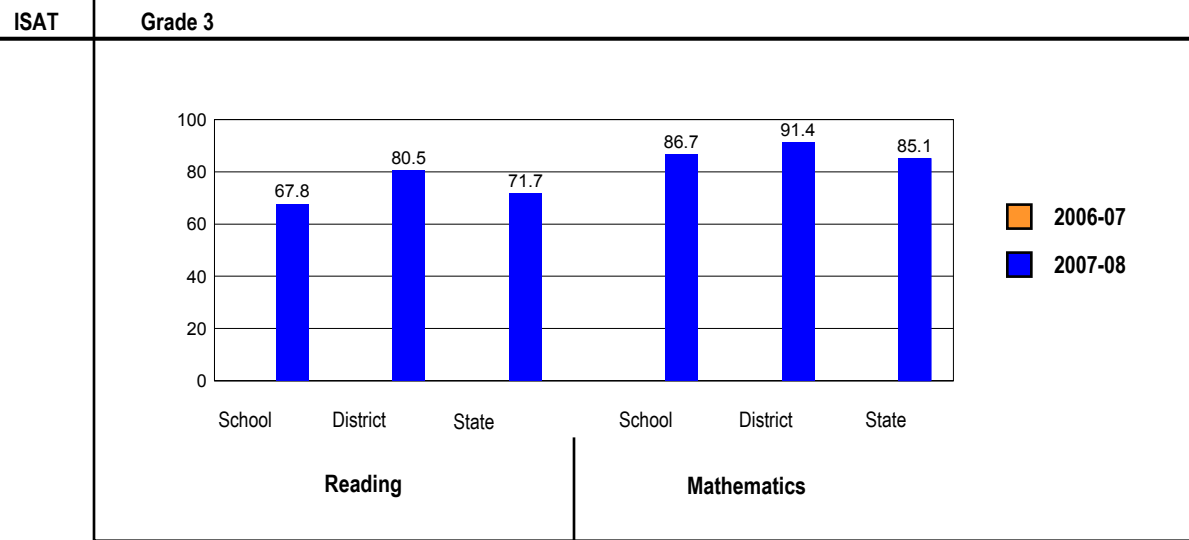


OVERALL ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT) PERFORMANCE

PERFORMANCE ON STATE ASSESSMENTS

Federal law requires that student achievement results for reading, mathematics, and science for schools providing Title I services be reported to the general public.

The Illinois Standards Achievement Test (ISAT) is administered to students in grades 3 through 8. The Prairie State Achievement Examination (PSAE) is administered to students in grade 11. The Illinois Alternate Assessment (IAA) is administered to students with disabilities whose Individualized Education Programs (IEPs) indicate that participation in the ISAT or PSAE would not be appropriate.

Students with disabilities have an IEP (No Child Left Behind Act). An IEP is a written plan for a child with a disability who is eligible to receive special education services under the Individuals with Disabilities Education Act.

Reading and Mathematics are tested in grades 3 through 8 and 11. Science is tested in grades 4, 7, and 11.

In order to protect students' identities, test data for groups of fewer than ten students are not reported.

ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT)

The following tables show the percentages of student scores in each of four performance levels. These levels were established with the help of Illinois educators who teach the grade levels and learning areas tested. Due to rounding, the sum of the percentages in the four performance levels may not always equal 100.

- Level 1 -- Academic Warning - Student work demonstrates limited knowledge and skills in the subject. Because of major gaps in learning, students apply knowledge and skills ineffectively.
- Level 2 -- Below Standards - Student work demonstrates basic knowledge and skills in the subject. However, because of gaps in learning, students apply knowledge and skills in limited ways.
- Level 3 -- Meets Standards - Student work demonstrates proficient knowledge and skills in the subject. Students effectively apply knowledge and skills to solve problems.
- Level 4 -- Exceeds Standards - Student work demonstrates advanced knowledge and skills in the subject. Students creatively apply knowledge and skills to solve problems and evaluate the results.

1. At least 95% tested in reading and mathematics for every student group. If the current year participation rate is less than 95%, this condition may be met if the average of the current and preceding year rates is at least 95%, or if the average of the current and two preceding years is at least 95%. Only actual participation rates are printed. If the participation rate printed is less than 95% and yet this school makes AYP, it means that the 95% condition was met by averaging.
2. At least 62.5% meeting/exceeding standards in reading and mathematics for every group. For any group with less than 62.5% meeting/exceeding standards, a 95% confidence interval was applied. Subgroups may meet this condition through Safe Harbor provisions. ***

- Parent contact is consistently at 100%.
- District #118 has maintained its commitment to low average classroom sizes across grade levels.
- Overall ISAT scores for Wauconda Grade School, grades 3 – 5 are 85.5%. This is 6.4% above the state average of 79.1%.
- 3rd grade Math scores, including LEP, IEP, and Economically Disadvantaged students are 86.7%, which is 1.6% above the state average of 85.1%.
- 4th grade Reading scores, including LEP, IEP, and Economically Disadvantaged students are 88.4%, which is 15.2% higher than the state average of 73.2%.
- 4th grade Math scores, including LEP, IEP, and Economically Disadvantaged students are 93.7%, which is 9.1% above the state average of 84.6%.
- 4th grade Science scores, including LEP, IEP, and Economically Disadvantaged students are 92.6%, which is 16.4% higher than the state average of 76.2%.
- 5th grade Reading scores, including LEP, IEP, and Economically Disadvantaged students, are 81.9%, which is 8.4% above the state average of 73.5%.
- 5th grade Math scores, including LEP, IEP, and Economically Disadvantaged students are 89.2%, which is 7.8% higher than the state average of 81.4%.

AREAS OF PLANNED IMPROVEMENT

- Identify and monitor students who did not meet ISAT standards in Reading, Math and Writing.
- Utilizing the Rtl model, provide and monitor interventions for Students with Disabilities, Limited English Proficiency, and Economically Disadvantaged students in the areas of Reading and Math in grades 3 – 5.
